Implied Equity Duration: A New Measure Of Equity Risk

$P + \sum_{t=1}^T \frac{CF_t}{(1+R)^t} = \frac{CF_T}{(1+R)^T} + P$ Where CF Denotes The Cash Flow At Time T, R Denotes The Yield To Maturity And P Denotes The Bond Price. This Measure Of Duration Is A Weighted Average Of The Times To Each Of The Respective Cash Flows On The Bond, Where The Weights Represent The Relative Contributions Of The Cash Flows To The Feb 5th, 2024
